At SPC:

- Masks must be worn at all times while in any SPC building.
- · Learning spaces have been set up to adhere to Physical Distancing (six feet or more).
- College Services will continue to staff check-in stations. All members and guests
 of our community must check-in, answer screening questions and have their
 temperature checked. Check-in stations are located at a designated entrance
 for buildings supporting F2F learning.
- Everyone is strongly encouraged to follow the guidance from health authorities and practice good hand hygiene, use CDC cleaning protocols, and maintain physical distance from people not in your household.
- We encourage our community to be aware of and remember the affects COVID-19 has had on our SPC family.



SPC Family Safety Performance

- Screening/Check-In Data
 - · SPC sees approximately 2,500 people on both campuses each week.
- COVID-19 Case Data:
 - Between March and December 2020, SPC received 170 reports of COVID-19 impacting our employees and students.
 - Between January 1 to February 21, 2021, SPC received 83 COVID-19 reports from our family members.
 - 37 Exposures Cases
 - · 8 Employees and 29 Students
 - 46 Positive Cases
 - · 12 Employees and 34 Students
 - · No onsite transmissions
 - SPC's 2021 case count in six weeks is more than 1/2 of the cases seen in 2020 in a ten month period.







Spring 2021 Plan

- ACD will remain at **Level 5-High Risk**.
- No on campus events will be held (Incident Command approved exceptions include: San Antonio Food Bank distribution, COVID-19 Testing/Vaccination, and academic supply distribution for students).
- SPC Welcome Center will continue to support our students and prospective students virtually.
- All meetings/trainings will be virtual.
- All travel is canceled.







Way Ahead

- Safety will continue to be SPC's #1 priority!
- Continue to operate at Level V.
- SPC will continue to control the # of people onsite to allow our CTE/CE students to complete their onsite program requirements, as we did in Fall 2020.
- Alamo Colleges will continue to monitor community COVID risk levels.
- Incident Command will assess and make a determination regarding our COVID-19 Risk Level for Maymester and Summer, as the local environment allows us to do so safely.
- Remote Work Requests approvals for Spring will be extended through Maymester and Summer 2021.
- IC, COVID TF and SPC will plan for varying levels of Fall 2021 onsite instruction
- SPC will continue to conduct its drive-through VITA tax preparation from February 8 – April 15, 2021.
